※郵寄申請注意事項/ Notice for Mailin Application :

1. 請填妥申請書並檢附新式統一證號之證件正反面影本乙份。

Please fill out the application form together with the copy of resident certificate which contains the New UI No. (both front and back copy).

2. 存戶申請異動時，需於申請人(存戶)欄位簽名並簽蓋與 貴行往來任一存款帳戶之原留印鑑後，將申請書逕寄申請人鄰近之分行辦理。

When the applicant applies for a change, the applicant(Depositor) needs to sign in and affix the original registered specimen seal, and mail the application form directly to the any nearby branch of FEIB.

3. 如申請書上申請人簽蓋之存款帳號之印鑑與 貴行原留存印鑑不符， 貴行得不受理存戶之申請。

If the seal of the deposit account signed by the applicant on the application does not match the original registered specimen seal, FEIB may not accept the depositor's application.

4. 提醒/Reminder

- (1)若申請人已申請個人網路銀行(含行動銀行 APP)，於收到遠銀統一證號變更完竣書面通知後，請至遠銀官網或行動銀行 APP 申請重製使用者代號及密碼；若申請人已申請無卡提款帳號服務者，因統一證號變更後將無法繼續使用此服務，申請人得利用遠銀 ATM 或請攜帶遠銀金融卡、載有新式統一證號之證件及原留印鑑至遠銀任一分行重新申辦。

If the applicant has applied for the Internet Banking (including the Mobile Banking APP), please visit the official website of FEIB or the Mobile Banking APP after receiving the notice of completion of change in UI No. to reproduce a user ID and PIN. If the applicant has already applied for a user ID and PIN for cardless withdrawal service, and cannot continue to use this service after the change of the UI No., the applicant may apply for a new user ID via the FEIB ATM or bring the FEIB banking card, resident certificate with the New UI No. and the original registered specimen seal to any FEIB branch to apply for a new user ID.

(2)若申請人已申請遠銀 COMBO 卡服務，因換發 COMBO 卡後需另外開啓金融卡功能，請務必攜帶載有新式統一證號之證件、換發後 COMBO 卡(如有)、存摺(如有)及原留印鑑至遠銀任一分行辦理資料變更。

If the applicant has already applied for COMBO card service with FEIB, and needs to activate the banking card function of the COMBO card after replacement for a new card, please bring the resident certificate with the applicant's New UI No., the new COMBO card (if any), passbook (if any) and the original registered specimen seal to any FEIB branch to handle matters related to the change of the New UI No..
