Q1(English)	I have changed to the New UI No. with the National Immigration Agency, <b>but my New UI No. have not been updated to the Far Eastern International Bank (“FEIB” or “the Bank”) yet. How should I proceed to update and what documents should I prepare?</b>

[Note]</p> <p>[Note] If you have already applied for the COMBO card service with FEIB, and need to activate the banking card function of the COMBO card after replacement for a new card, please bring the resident certificate with the New UI No., the new COMBO card (if any), passbook (if any) and the original registered specimen seal to any FEIB’s branch to handle matters related to the change of the New UI No..</p> <p>2. Please bring your resident certificate with your New UI No., passbook (if any) and the original registered specimen seal to any FEIB’s branch to handle matters related to the change of the New UI No..</p> <p>◆For information on the address and telephone number of the branches, visit the</p>

Q2(English)	I have changed to the New UI No. with the National Immigration Administration, <b>but my New UI No. have not been updated to the Bank yet, what kind of business will be affected? Is there a deadline for the update? Could I appoint a third party to update on my behalf?</b>
A2	親愛的客戶，您好： 一、建議您辦理統一證號變更後，請您與有入 / 扣帳往來之相關單位（如：發薪雇主、公共事業費機關、證券公司或保險公司等）同步更新您的統一證號，以利後續順利辦理入帳或扣帳作業。 二、本行目前並無規定變更統一證號之期限。惟為維護您的權益，建議您撥冗向本行辦理變更事宜，以利您個人資料管理之一致性。 三、變更統一證號需由您本人辦理，無法委託他人代辦。您可以透過臨櫃或郵寄的方式辦理。
A2(English)	Dear Customer,  1. After the finish of the change of the New UI No., please also update your New UI No. with the relevant units where you have debit/credit transactions (e.g., payroll employers, public utilities service providers, securities companies or insurance companies) to facilitate the smooth processing of the subsequent debit and credit operations. 2. The Bank has not set a deadline for the update of UI No.. For the protection of your rights and privileges, you are advised to make time for the update with the Bank for the consistent management of our personal information. 3. You have to process the update the UI No. in person and cannot appoint a third party for this purpose. You may process the change at any of our branches or by mail delivery.

Q3(English)	<b>I have received a notice from the Bank for the update of credit card ID recently, what should I do? What documents should I prepare?</b>
A3	親愛的客戶，您好： 您可透過下列任一方式辦理變更事宜： 一、本人親持護照及載有新式統一證號之證件至本行任一分行臨櫃辦理。 ◆分行地址及電話可參閱本行網站>服務據點>分行據點。 二、檢附護照、載有新式統一證號之證件影本，並郵寄至「220 板橋郵政 6-9 號信箱」。 三、撥打本行客服專線(02-80731166/0800-261-732)，並傳真(02-82571800) 護照及載有新式統一證號之證件。

After the update of ID, the Bank will issue you new card(s). You should apply once again for related automatic preauthorized payment.
