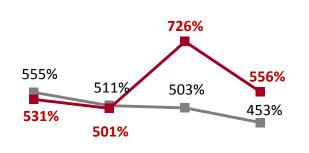


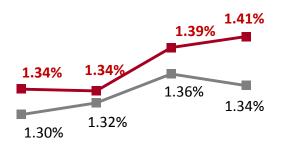
NPL Ratio

Loan Coverage Ratio







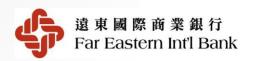

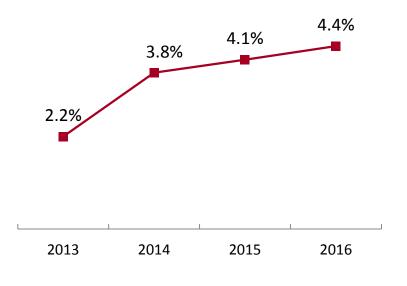


EPS & dividend payout

Cash dividend yield *



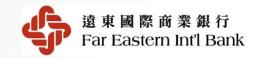

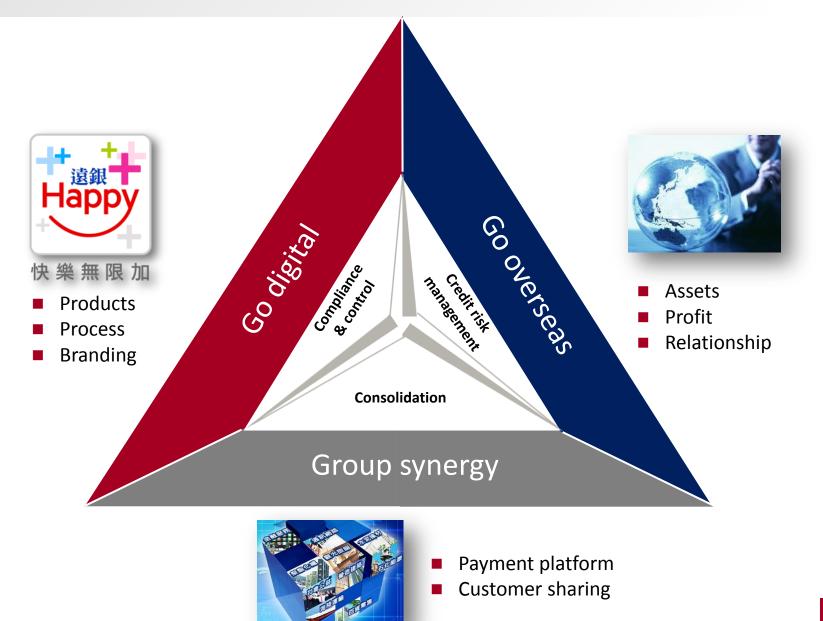

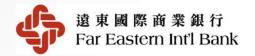
